Notice Regarding the Introduction of a Shareholder Benefit Program

The Company inc. (Head Office: Chiyoda-ku, Tokyo; President and Representative Director: Hideo Misawa, "the Company") hereby announces that at a meeting of its Board of Directors held on November 14, 2025, it resolved to introduce a shareholder benefit program as detailed below.

1. Purpose of Introducing the Shareholder Benefit Program

The Company has decided to introduce this Shareholder Benefit Program to express our gratitude for the ongoing support of our shareholders, to enhance the appeal of investing in our shares, and to encourage more investors to hold our shares over the medium-long term.

2. Overview of the Shareholder Benefit Program

(1) Record Date

The initial record date will be the last day of December 2025, and subsequently, the record date will be the last day of December each year.

(2) Eligible Shareholders

Listed shareholders in the company's shareholder register as holding 100 shares (1 share unit) or more as of the last day of December each year will be eligible.

(3) Details of the Benefit

Eligible shareholders will be presented with a benefit voucher for the "Smart Brain Dock" (note) that brain checkup service operated by our company, its service aims for the early detection and prevention of cerebral diseases, which are known to be highly correlated with chronic diseases.
